The mean course evaluation ratings listed below reflect student responses to the question "Overall, this is an excellent instructor" on a 4-point scale from *Strongly Disagree* (1) to *Strongly Agree* (4). In addition to evaluating students' ratings of my performance as an instructor, I frequently measure whether students' knowledge of the subject matter increases after completing the course. To do this, students complete a 10-item test of basic course material on the first and last day of class. The mean scores of these evaluations on the first day of class are generally around 4/10 and on the last day of class are around 9/10, indicating that students learn over the course of the semester.
